2.0 QUALIFYING REQUIREMENTS:

2.1 PQR-1:

The bidder who have designed, manufactured, supplied, installed, tested and commissioned at least one number of training simulator for crawler mounted 1400 lit Bucket Wheel Excavator and the same should have worked satisfactorily for at least one year as on the original scheduled date of tender opening.

(or)

- 2.2 A bidder who does not meet the above qualifying requirement can also participate if he has designed, manufactured, supplied, erected, tested and commissioned at least one number of crawler mounted 1400 lit Bucket Wheel Excavator and the same should have worked satisfactorily for at least one year as on the original scheduled date of tender opening and shall have a valid collaboration agreement/consortium agreement with collaborator(s)/ consortium member(s) who have designed, manufactured, supplied, installed, tested and commissioned one number of training simulator for crawler mounted 1400 ltr BWE /Dozer/ Hydraulic shovel / Pipe layer. The bidder shall furnish an undertaking jointly (JDU) executed by him and his collaborator(s)/ consortium member(s) to guarantee the standards of performance of the simulators as detailed in the tender specification along with bid. Such JDU shall be in force as on the scheduled original tender opening date and shall be further valid up to the completion of the proposed contract.

2.3 PQR-2

In case of the bidder getting qualified with the experience of training simulator for Dozer/ Hydraulic shovel/Pipe layer, the bidder shall have a valid collaboration agreement/consortium agreement/ agreement with collaborator(s)/consortium member(s) who designed, manufactured, supplied, erected, tested and commissioned one number 1400 lit crawler mounted Bucket Wheel Excavator and the same should have worked satisfactorily for at least one year as on the original scheduled date of tender opening. The bidder shall furnish an undertaking jointly (JDU) executed by him with collaborator /consortium member to guarantee the standards of performance of the simulators as detailed in the tender specification along with bid. Such JDU shall be in force as on the scheduled original tender opening date and shall be further valid up to the completion of the proposed contract.

2.4 PQR-3:

The bidder who does not meet the above qualifying requirements, can also participate along with an associate, if the associate is the Parent/Principal/ Group company of the bidder (who fully meets the qualifying requirements singly or jointly i.e the associate by themselves or along with the bidder, stipulated as in PQR-1/PQR-2 as above). However, in such cases, the bidder and his associate shall furnish a joint deed of undertaking to guarantee for the standards of performance of the simulator as detailed in the tender specification. Such JDU shall be in force as on the scheduled original tender opening date and shall be further valid up to the completion of the proposed contract.

2.5 PQR-4:

Average annual turnover of the bidder, combined average annual turnover of their collaborator(s)/ associate/ consortium member(s) as the case maybe in the preceding three consecutive financial years as on the original scheduled date of tender opening, shall not be less than Rs 5.11 Crores.

3.0 **DOCUMENTARY EVIDENCES:**

Copy of order / agreement with value and detailed scope of work, relevant certificate and performance certificate indicating period of work from end user satisfying PQR-1. Copy of audited annual financial reports/balance sheets certified by chartered accountant for the period indicated in PQR-4.

3.1 Bids which are submitted without proper documentary evidence to substantiate fulfilment of the qualifying requirements as specified are likely to be rejected without assigning any reasons.

3.2 Notwithstanding anything stated above, the purchaser reserves the right to assess the bidder's capacity and capability to perform the contract, should the circumstances warrant such an assessment in the overall interest of the purchaser.

4.0 **SPECIAL CONDITIONS:**

- 4.1 The successful Bidder(s) shall carry out the work by themselves by utilizing employees on their rolls. The Successful bidder(s) shall satisfy themselves that there is presently no legal or other impediment for the satisfactory execution of the Work as contemplated under the contract.
- 4.2 The Successful bidder shall not engage any Contract Labour within the purview of the Contract Labour (Regulation and Abolition) Act, 1970, but shall carry out the work with the workmen who are on the regular rolls of bidder's company.
- 4.3 The Successful bidder shall obtain all necessary license/ permission/ consent/ exemption under applicable local and other laws, including under the Contract Labour (Regulation and Abolition) Act, 1970.
- 4.4 It shall be the responsibility of the Successful bidder to comply with all applicable laws, including but not limited to the Mines Act, 1952, and the Coal Mines Regulations, 1957, as in force from time to time.
- 4.5 The Successful bidder should be ready and able to mobilize and deploy additional fleet of equipment and personnel, if required.

5.0 **OTHER CONDITIONS:**

- 5.1 Contract will be entered into only with the entity submitting the Bid and no request for change in name or composition will be entertained after submission of the Bid for the entire period of the contract.
- 5.2 The Bidder shall, in such an eventuality submit along with the bid, a Letter of Consent/expressions of intentions, signed jointly with the associate/collaborator/consortium members as the case may be, for undertaking the tendered work jointly and for the successful performance of the Contract if awarded. If the Bid is finally accepted, a LOA would be issued, only after such Bidder has furnished a Deed of Undertaking executed jointly with the associate/collaborator/consortium members as the case may be, for the successful performance of the Contract as per Appendix – F on a stamp paper of appropriate value. Such Deed shall remain valid till the completion of all the obligations under the Contract and shall be such as to make the Bidder together with associate/collaborator/consortium member as the case may be jointly and severally liable to NLCIL to perform all the contractual obligations pertaining to the scope of the work.
- 5.3 In case of award of the Contract, every associate/collaborator/consortium members, as the case may be shall be required to furnish a back up Contract Performance Guarantee for 5% of the total Contract Price (**as per format Appendix-J**) in addition to the Faithful Performance of the Contract Guarantee (CPG) for 10% of the total Contract Price, to be furnished by the Bidder in the form as given under relevant clause of General

Commercial conditions of the Tender. All such guarantees shall be kept valid till the completion of all the obligations under the Contract.

5.4 No change in the Constitution of the consortium shall be allowed during the tenure of the contract. However, in the event of any eventuality that any of the members other than the lead member in the consortium is unable to continue till the completion of the contract, change in consortium members will be subject to the incoming member possessing equivalent or more qualifying requirement of the outgoing consortium member on which the consortium fulfilled the qualifying requirements and approval of NLCIL.

5.5 The bidder cannot be an associate/collaborator/consortium member for other bidder(s) who are bidding for this tender.

6.0 **SCOPE OF WORK:**

The scope of work of this tender is to Design, Manufacture, Supply, installation, testing, commissioning of one number of Basis Simulator each for 1400Ltr Bucket Wheel Excavator, Dozer, Hydraulic shovel and Pipe layer (E- Learning) for NLCIL along with training as per the terms and conditions of the tender. This scope of work is only indicative. Detailed Scope of work is given under Technical Specification and Condition of the Contract.

7.0 **TIME SCHEDULE:** The simulator must be supplied, installed tested and commissioned within a period of 09 (Nine months) from the date of LOA as detailed below :-
